Cancellations and refunds

- Any bookings cancelled within 7 days of the intended booking date will forfeit either their full food deposit or incur a cancellation fee of \$200.
- Upon the day of booking if your group does not attend Mash you will be charged a non-attendance fee of \$200.
- Any possible refunds will be at the discretion of the Venue Manager

Anti-Social behaviour and RSA guidelines

Please be advised that if upon arrival your group is either intoxicated, under the influence or acting out in any way you will be denied entry by the authorisation of the Manager on duty, then be charged a refused entry fee of \$200.

Any damage to the venue will be charged accordingly.
